TO: Camelot Hostel LLC owners, employees, agents, Independent contractors, subcontractors, representatives, (all of whom are hereinafter collectively referred to as "THE RELEASEES").

RENTAL AGREEMENT: I accept full responsibility for the rental equipment. I agree to pay for any damage and replace the equipment at full retail value if not returned by the agreed date and time.

ASSUMPTION OF RISKS: Injuries are a common and expected part of biking. Biking will expose the rider to many risks, dangers and hazards including but not limited to: mechanical failure of bicycles; Improperly adjusted or maintained equipment; variation or steepness in terrain; Inability to control speed and direction; loss of balance; collisions with man made and natural objects including trees and rocks; collision with vehicles, cyclists or other persons; encounters with dogs or wild animals and NEGLIGENCE ON THE PART OF THE RELEASEES, INCLUDING FAILURE ON THE PART OF THE RELEASEES TO TAKE REASONABLE STEPS TO PROTECT OR SAFEGUARD ME FROM THE RISKS, DANGERS AND HAZARDS OF BIKING RELEASE OF LIABILITY, WAIVER OF CLAIMS AND INDEMNITY AGREEMENT In consideration of the rental of the Equipment, I hereby agree as follows:

(1) TO HOLD HARMLESS AND INDEMNIFY THE RELEASEES from any and all liability for any damage to property of or personal injury to any third party, resulting from my use of the Equipment; (2) This Agreement shall be effective and binding upon my heirs, next of kin, executors, administrators and representatives, in the event of my death or incapacity; (3) This Agreement and any rights, duties and obligations as between the parties to this Agreement shall be governed by and interpreted solely in accordance with the laws of the State of Utah and;

(4) Any litigation involving the parties to this Agreement shall be brought solely within the exclusive jurisdiction of the Courts of the State of Utah. I HAVE READ AND UNDERSTAND THIS AGREEMENT AND I AM AWARE THAT BY SIGNING THIS AGREEMENT I AM WAIVING CERTAIN LEGAL RIGHTS WHICH I OR MY HEIRS, NEXT OF KIN, EXECUTORS, ADMINISTRATORS AND REPRESENTATIVES MAY HAVE AGAINST THE RELEASEES.

I AGREE TO WAIVE ANY AND ALL CLAIMS that I have or may in the future have against the Releasees and TO RELEASE THE RELEASEES from any and all liability for any damage, expense or Injury Including death that I may suffer, or that my next of kin may suffer, resulting from or arising out of any aspect of my use of the Equipment, DUE TO ANY CAUSE WHATSOEVER, INCLUDING NEGLIGENCE, BREACH OF CONTRACT OR DEFECTIVE EQUIPMENT, In respect of the selection or maintenance of the Equipment or in respect of the provision or failure to provide any warnings, directions or Instructions as to biking safety or the use of the rental equipment.
